POSITIVE PROFIT ALERT

This announcement is made by Tysan Holdings Limited (the “**Company**” and, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders and potential investors of the Company that, based on a preliminary review of the unaudited consolidated management accounts of the Group for the year ended 31 December 2025 (the “**Management Accounts**”) and the management’s preliminary assessment of such Management Accounts, the Group is expected to record an increase in net profit to around HK\$60 million for the year ended 31 December 2025, as compared with a net profit of around HK\$40.8 million for the year ended 31 December 2024.

The increase in net profit for the year ended 31 December 2025 as compared with the net profit for the year ended 31 December 2024 was mainly attributable to the improvement in the gross profit margin of the foundation piling segment for the year ended 31 December 2025.

As the Company is in the course of finalising the Management Accounts, information in this announcement regarding the estimated financial results of the Group for the year ended 31 December 2025 is based only on a preliminary assessment by the management of the Company with reference to the information currently available to the Company, including the Management Accounts and is not based on any figure or information audited or reviewed by the Company’s independent auditors, and may therefore be subject to changes.

Shareholders and potential investors of the Company are advised to exercise caution in dealing in the securities of the Company.
